- 2. Apologies: Cllrs. S. Parker and A. Woollard The apologies were accepted
- 3. Absent: Nil
- 4. Public Question Time: There were no members of the public present.
- 5. Declarations of Interest/Chairman's announcements: Nil
- **<u>6.</u> <u>Minutes</u>**: The Minutes of the meetings held on 13<sup>th</sup> and 30<sup>th</sup> September 2021 were taken as read and signed as being true records.
- 7. Matters Arising:
  - a. <u>Enforcement matters</u>: The Clerk updated the Committee on the current enforcement issues – three relating to Quarry Woods, one to Henley Court Stables and one to Thistle Barn, Ashley
  - **b.** <u>Notice Boards</u>: The notice board in The Pound needs repainting. This has been added to the list of winter tasks. It was reported that all the notice boards need cleaning and Councillors were asked to look at the boards that they are responsible for.
  - **Blind House**: it was reported that the bed frame has rotted and the new slats cannot be put on. Clerk to contact English Heritage to see if Scheduled Monument approval is required.
    <u>Viewing Platform</u>: Regular checks on the condition of the Viewing Platform to
    - be carried out The Fountain; The work had been completed
  - d. <u>Risk Assessment:</u> To be updated next April
  - e. <u>Bus shelters:</u> Cllr Campbell is waiting for the final copy of the map and this will then be circulated. The notice boards and grit bins will be added to other plans
  - f. <u>Rudloe No 2 Site</u>; Corsham Town Council are still trying to set up a further meeting with Bellway. Clerk to ask Corsham TC to involve Cllr Walters in this.

The group will be trying to get representatives from the different areas of the Parish to help to definie the individual characteristics of these areas. PL/2021/08718	Cyfaleah, Ashley Extensions and alternations to existing bungalow, comprising the extension of the first floor storey, the erection of a rear extension and attached garage and works to the front boundary
	Strong objections. This is gross over development of the site with an increase of 96% volume plus an additional garage and raising the roof by $\frac{1}{2}$ m. This is in the National Landscape (AoNB) and on the edge of the Conservation Area
PL/2021/08776	7 High Street, Box Extension of land to accommodate further parking
	No objections but would comment that a new fence has been erected which is not shown on the plan
PL/2021/09040	Stonehey, Ashley, Box Removal of existing house roof, build new replacement roof, additional of first floor to building within new roof space, garage conversion and house refurbishment to ground floor

PL/2021/09093 1 Roman Villas, Church Lane, Box Demolition of existing kitchen extension, replacement of larger flat roof wrap round extension, and creation of new downstairs bathroom extension

PL/2021/09548 8 Clift Close, Corsham Fell Ash tree – consent under TPO

There is no evidence of Ash die back so the Parish Council objects to the feling of this tree. It is recommended that this should be pollarded professionally
